



BOROUGH OF NORTH HALEDON

COUNCIL MEETING MINUTES

MONDAY, DECEMBER 30, 2013

Mayor George called the adjourned meeting of December 11, 2013 to order at 7:00 p.m.

PUBLIC COMMENTS

Motion by Councilman Iacobelli, second by Councilwoman Vuoncino, to open the floor to the public. Upon roll call, all members present voted in the affirmative. Motion carried.

Former Mayor Renate Lampe, 77 School Street, thanked Councilman Iacobelli and Councilwoman Vuoncino for their service as council members.

Beth Antoci, 30 Indian Trail, thanked Council Members Iacobelli and Vuoncino for their service. She discussed the results of the general election, as well as the use of a generator by the Mayor, alleged bullying tactics, and the status of the members of former Fire Company No. 1.

Stacey Weil Barbarito, 51 Morningside Drive, alleged that she had filed an OPRA request for the report of the Municipal Investigatory Committee, but that she had never received it; she then elaborated and said that she had asked someone to file the OPRA request for her, and that she never did file an OPRA request herself. Mrs. Barbarito claimed that she hadn't been allowed to speak to the Municipal Investigatory Committee (MIC). Councilman Iacobelli advised that there had been a public portion at every meeting of the MIC, and that she had never tried to speak. Mrs. Barbarito challenged Councilman Dyer's absence on the MIC; Councilman Iacobelli advised that he had been

excluded because he had been quoted in the press making prejudicial statements. Mrs. Barbarito challenged the role and influence of the Police Commissioner; Councilwoman Puglisi advised that she is the council representative to the Police Department, and that no one has the authority to give orders to the Police Department. Mrs. Barbarito expressed her opinion that the applications submitted by former members of Fire Company No. 1 had been rejected by the Fire Chief because he was prejudiced against them. Mrs. Barbarito alleged that the Fire Chief had to always remain in town and that she believed that there was a conflict with the Fire Chief working in Paterson. Mayor George explained that there was a chain of command in the Fire Department regarding response to fire calls, and that there had been no loss of life or property as a result of the Fire Chief working in Paterson. Mrs. Barbarito complained that fund-raising firemen had rang her doorbell despite her light being switched off; she was advised by the Mayor to write a letter to the Fire Department asking them not to come to her house when fund-raising.

Angelo Cifaldi, 60 Ridge Road, thanked Council Members Iacobelli and Vuoncino for their many years of dedicated service. He advised that 25 years ago, he had been Police Commissioner, and confirmed, also as an attorney, that elected officials cannot interfere with Police Department operations.

Fire Chief A. J. Ricciardi, 12 Rosslee Avenue, went over each application that had been submitted and explained why some had been rejected, and advised that some applications had been accepted, but there was no follow-up by the applicants; that no one had participated in the activation period, and therefore the minimum number of firefighters for former Fire Company No. 1 had not been reached.

Mayor George advised that the members of the Governing Body were bound by the settlement agreement to make a determination of the members of former Fire Company No. 1 had adhered to the settlement agreement or not. The members of former Fire Company No. 1 then had 30 days to appeal that determination. Councilman Dyer inquired whether that determination could not make a ruling regarding the settlement agreement. Mayor George advised that article 14 of the agreement clearly stated that the Governing Body had to make a determination. The Borough Attorney had sent three letters to the Attorney of the members of former Fire Company No. 1 asking to meet to discuss the application process, but that he had never responded to any of the correspondence.

Councilman Dyer inquired why there were two separate applications for the Fire Department. The Fire Chief explained that the application handed to the members of former Fire Company No. 1 did not include becoming a social member of the High Mountain Fire House since they were already social members of their own fire company. He advised that neither he nor the members of the Governing Body have any say in the social arm of the Fire Houses.

Councilman Luisi advised that even if all seven applicants had successfully completed the application status, there still would not have been enough fire fighters to have met the terms of the consent judgment.

Antonio Valenti, 60 Manchester Avenue, explained how he had failed to fill out the application correctly (i.e., he did not give his firefighter ID number and he checked off that his physical health would prevent him from becoming a firefighter) and complained the difficulty he had in filling out the application. The Fire Chief advised that he could have asked for help in filling out the application. Mayor George advised that his attorney could rebut the Fire Chief's determination, but that he

should have submitted a corrected application. Mr. Valenti further alleged that the Fire Chief was biased against the members of former Fire Company No. 1 and that was why there was a drop in the roster of former Fire Company No. 1. Councilman Luisi advised that a judge will make that determination. Mayor George asked Mr. Valenti for documentation of the alleged bias, and Mr. Valenti responded that he did not have any. Mr. Valenti also stated that he was able to fill out the Haledon application form correctly when he joined the Haledon Fire Department, and had included his firematic number and filled in the box that his physical help wouldn't prevent from becoming a fireman.

John Bleeker, 23 Lee Drive, advised that he wanted this issue discussed with the new council members, and warned that this issue will be rolled into the next election cycle. Mr. Bleeker explained why he had filled out the application the way he had and alleged that the application process had been changed after the consent judgment had been signed. He alleged that he had 10 new applications in his hand.

Councilwoman Vuoncino responded that they had signed the consent judgment, and that it was time for Mr. Bleeker to admit that the members of former Fire Company No. 1 had not done what they were supposed to do. They had been given an opportunity, but those not to take it. As for the drop in the roster of former Fire Company No. 1, she advised that it was up to the individual firefighters to remain firematic.

Mayor George advised that a judge is going to make the final decision and that the members of the Governing Body simply had to make a determination if the terms of the consent judgment had been met. He asked why the 10 applications had never been submitted to the Fire Chief during the time frame allotted in the settlement agreement.

Councilman Luisi responded to Mr. Bleeker's comments and advised that his suggestion that the Mayor and Council do things for political reasons was deplorable, and that the Council Members vote on what is put before them. He went on to remind Mr. Bleeker that he has been the plaintiff and that he is the one who is costing tax payers money.

Mayor George reiterated that all the members of former Fire Company No. 1 had to do was go to the Fire House on High Mountain Road for 12 months and they didn't do it.

Fire Chief A. J. Ricciardi advised that if the members of former Fire Company No. 1 were sincerely concerned about public safety, they would have joined the Fire Department and actively participated. They could have followed grievance procedure that was in place.

Michael LaBarck, 41 Louise Place, agreed with the Fire Chief and said that if you want to fight fires you have to join a fire department, and that was why he had joined the Wyckoff Fire Department. He wondered if there was any way for the members of former Fire Company No. 1 not to lose their fire house. Mayor George explained that that had been the whole reason behind the consent judgment. Councilwoman Puglisi responded that all that any member of former Fire Company No. 1 had to do was go for training and drills and that none of this would have happened and that it was sad that it had come to this this, and that is was a shame that he was a fire fighter in another town.

Paul Valenti, 183 Highland Road, commented on the loss of volunteers to other towns and that they may come back and fight fires alongside members of the North Haledon Fire Department. He alleged

Councilman Luisi advised Councilman Dyer that he had the options to vote no or abstain.

Motion by Councilwoman Vuoncino, second by Councilman Iacobelli, to adopt the foregoing resolution. Upon roll call, all members present voted in the affirmative. Motion carried.

Motion by Councilman Iacobelli, second by Councilwoman Vuoncino, to approve the minutes of the Executive Committee Meetings of November 6, 2013, and December 11, 2013 (in drawers), the work session meeting of November 6, 2013, the regular council meeting of November 6, 2013, the work session meeting of December 11, 2013, and the regular council meeting of December 11, 2013. Upon roll call, all members present voted in the affirmative. Motion carried.

COMMUNICATIONS

Passaic County Prosecutor's Office / Use of Borough Owned Generators / Mayor Randy George & Chief Robert Bracco. Passaic County Prosecutor's Office advised that they had "concluded that there is insufficient evidence for this office to initiate a criminal prosecution regarding this matter."

Barry N. Handwerger, Esq. / Schaefer Pyrotechnics vs. Borough of North Haledon. Attorney advised that Schaeffer Pyrotechnics had decided not to proceed with the appeal. Accordingly, this file is now closed.

Borough Attorney / North Haledon Fire Company No. 1 vs. Borough of North Haledon. The Borough Attorney gave formal notice to the attorney of the members of former Fire Company No. 1 that the Governing Body would be making its formal determination regarding satisfaction of the eligibility criteria pursuant to the terms of the consent judgment at its December 30, 2013 meeting.

Chairman, Ethics Board / Request for Monies. The Chairman of the North Haledon Ethics Board requested that funds be put into the 2014 Municipal Budget because the Board needed funds to hire an attorney to hear complaints.

Borough Attorney / Recycling. The Borough Attorney wrote Galaxy Recycling a letter demanding payment of \$3,584.04 for fines for missed stops and Borough incurred cost of DPW employees collecting the missed recycling.

Fire Official/Code Enforcement Officer / Incident Command Training in Texas. Jim Booth submitted a description of the course he will be attending in Texas.

Albert Zaccone / ADAing of American Legion Building. After reviewing the bids for the renovations at the American Legion Building, he suggested that the bid be awarded to LKL Contracting.

North Haledon Planning Board / Resolution / The Tides Estate. The Planning Board approved the applicant's site plan.

Treasurer / November Treasurer's Report.Self-explanatory.

North Haledon Free Public Library / Request for January - March Allotment. The Library Director submitted a letter requesting funds for library purposes for January through March 2014.

Joanne Panicucci / Letter of Resignation. Mrs Panicucci's resignation will be accepted with regret.

Steven Marcus / Request for Speed Bumps on Saw Mill Road. Mr. Marcus is urging the Mayor to put speed bumps on Saw Mill Road.

NJDEP / Passaic River Litigation. 261 third-party defendants (including the Borough of North Haledon will collectively pay the State \$35.4 million for costs associated with the Passaic River cleanup.

Resolution #281-2013**Re: Use of Borough-Owned Property**

WHEREAS, the Borough of North Haledon has determined that it is in the best interests of the Borough to prohibit the personal and/or business use of all personal property, equipment, appliances and assets owned by the Borough of North Haledon;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and the Board of Council of the Borough of North Haledon that all personal property, equipment, appliances and assets owned by the Borough of North Haledon shall be used only for official Borough business and only by duly authorized Borough officials and/or employees and any personal and/or non-business use of same in any manner whatsoever by any individual, including, but not limited to any Borough official and/or employee, without the prior approval of the Mayor or authorization as provided by ordinance or resolution is hereby prohibited.

Resolution #282-2013**Re: Amendment / Shared Services Agreement**

WHEREAS, the Uniform Shared Services and Consolidation Act, NJSA 40A:65-1 governs shared services between municipalities.

WHEREAS, the Borough of North Haledon (NH) and the Township of Wyckoff (W) wish to modify an agreement under the authority of the Act whereby NH furnishes and provides to W services of an Electrical Sub-Code Official in consideration for payment.

NOW THEREFORE, it is agreed by and between the parties that the following sections in this agreement are modified as follows:

Section 1**Term of Agreement**

This Agreement shall be extended to have a conclusion date of December 31, 2016. Either party may cancel this agreement upon ninety (90) days written notice to either party.

Section 2**Funding**

This Agreement is hereby modified accordingly that effective January 1, 2014, W agrees to pay to NH thirty thousand dollars (\$30,000) per annum for electrical sub-code services. Payment for the thirty thousand dollars (\$30,000) shall be payable quarterly on February 1, May 1, August 1 and November 1 of each remaining calendar year of the agreement through December 31, 2016.

In the event the Township of Wyckoff receives revenue from electrical sub-code fees in a calendar year that exceeds one hundred ten thousand dollars (\$110,000) up to two hundred thousand dollars (\$200,000), W agrees to make an additional payment of 20% of

the amount of revenue received between one hundred ten thousand dollars (\$110,000) to two hundred thousand dollars (\$200,000) to NH. This payment shall be made by W to NH before February 1 of the immediate next year.

Such payment shall be full and complete compensation to NH for all costs incurred by NH in the performance of this agreement.

Section 3

All other sections remain unchanged and in effect.
